## PROGRAM CHANGES

Additional appliances have been added effective 6/28/10.

Clothes washer rebate amount increased to \$150.

Customers who have received a \$100 rebate for a clothes washer will automatically receive an additional \$50 check.

## IMPORTANT INFORMATION

Funds are limited and available on a first-come, first-served basis.

Rebate may be combined with existing utility rebates.

Appliances must replace existing models and cannot be first-time purchases.

Contractors must complete the Contractor Installation Details portion of the application for heat pump water heaters, gas tankless water heaters and ductless heat pumps.

A separate Decommissioning/Recycling receipt is required for refrigerators.

See Terms and Conditions for additional eligibility requirements and program details.

## BEFORE YOU BEGIN

**Incomplete applications will be returned. You may resubmit a completed application, which will be processed in the order received, while funds last. If an application is rejected, funds are not held until an accepted form is processed.**

### 1. ENSURE YOUR ELIGIBILITY

- Clothes Washers and Refrigerators must be purchased on or after March 15, 2010; all other qualifying appliances must be purchased on or after June 28, 2010.
- Appliance must be installed in a Washington residence.
- If appliance is purchased online or out of state, proof of Washington State sales tax is required, unless receipt shows appliance was installed by a licensed contractor.
- Additional qualifying customer details are outlined in the Terms and Conditions section.

### 3. INCLUDE SUPPORTING DOCUMENTS WITH YOUR APPLICATION **Incomplete applications will be returned.**

- Completed and signed application including Contractor Installation Details for Heat Pump Water Heaters, Gas Tankless Water Heaters and Ductless Heat Pumps.
- Itemized purchase receipt indicating retailer name, address and phone number, purchase date and price, product make and model, and Washington State sales tax amount paid unless receipt shows the appliance was installed by a licensed contractor.
- Copy of Washington state ID or utility bill (dated 90 days or less from appliance purchase date) that shows applicant name and current installation address in the State of Washington. Name and address on proof of ID must match name and address on this rebate form.
- If applying for a refrigerator rebate, two receipts are needed: one receipt from the retailer and a separate receipt from the haul away or drop off site. In the case where a receipt from the haul away or drop off site is not available, a signature from their representative is required below.

**For completion by Representative of haul-away company or drop-off site: (this is required only if a receipt is not available)** I certify that this appliance will be removed from the grid (not resold or reused), and recycled or decommissioned according to Washington State disposal laws, including the appropriate recycling of all CFCs.

## TERMS & CONDITIONS

**Rebate Availability:** Rebates are available first come, first served, according to date received, until funds run out. Please reference the program website at [www.cashforapplianceswa.com](http://www.cashforapplianceswa.com) or call (877) 304-9225 to determine current status of fund availability. Rebate will not exceed purchase price. Applications must include all information requested. It is the responsibility of the applicant to submit a complete application. Incomplete applications will be returned to the applicant with a detailed explanation of why the application was returned and how to reapply. Additional terms and conditions may apply.

**Rebate Eligibility:** This is an appliance replacement program available to Washington residents for Washington residences. Limit one appliance, per type of appliance, per household. Landlords and property managers are considered businesses under this program and therefore are not eligible to receive a rebate. Washington State sales tax must be paid unless the appliance is purchased at a Washington military exchange or from a Washington retailer and have a Native American exemption, or unless appliance is purchased and installed by a licensed contractor.

Purchases made outside of Washington State or online require proof of paid Washington State sales tax. Rebates are available for Clothes Washers and Refrigerators purchased and installed on or after March 15, 2010, and for Dishwashers, Gas Storage Water Heaters, Gas Tankless Water Heaters, Heat Pump Water Heaters and Ductless Air Source Water Heaters purchased and installed on or after June 28, 2010. Rebates are not retroactive. All equipment must be new and have been purchased and installed prior to submitting a rebate application.

### Specific Appliance Eligibility Requirements:

**Clothes Washer** – The appliance must be ENERGY STAR® rated and have a Modified Energy Factor (MEF) of 2.46 or greater, and a Water Factor (WF) of 4.0 or less.

**Refrigerator** – The appliance must be ENERGY STAR® rated and be 9 cubic feet or greater. Documentation that the unit has been recycled or decommissioned in accordance with Washington State disposal laws is required. In cases where documentation is not available, a signature from a representative of the haul-away company or drop-off site is required.

**Dishwasher** – The appliance must be ENERGY STAR® rated and operate at 307 kWh or less per year and 5 gallons or less per cycle.

**Gas Storage Water Heater** – The appliance must be ENERGY STAR® rated and have an Energy Factor (EF) of 0.67 or greater.

**Gas Tankless Water Heater** – The appliance must be ENERGY STAR® rated, have an Energy Factor (EF) of 0.90 or greater and must be installed by a licensed contractor. Contractors must complete the Contractor Installation Details portion of the application.

**Heat Pump Water Heater** – The appliance must be ENERGY STAR® rated and have an Energy Factor (EF) of 2.0 or greater, and must be installed by a licensed contractor. Manufacturer's specifications and local building codes apply. Contractors must complete the Contractor Installation Details portion of the application and include photographs of the installed unit to verify proper installation.

**Ductless Air Source Heat Pump** – The appliance must be an ENERGY STAR® rated inverter-driven ductless heat pump that replaces a primary heat source. It must be installed by a licensed contractor who has been trained on the NW Ductless Heat Pump Project. Some units contain both Outdoor and Indoor model and serial numbers. Outdoor model and serial numbers, and Indoor model and serial numbers where available, are required on the application. Contractors must complete the Contractor Installation Details portion of the application.

**Proof of Purchase:** A dated invoice/sale receipt itemizing the purchased appliance must accompany each rebate application. The invoice/sale receipt copy must indicate the manufacturer, model numbers, purchase price, date of purchase and Washington sales tax amount paid. If Washington State sales tax is not paid on the purchase receipt, customers may submit sales tax payment to the Washington State Department of revenue, and submit receipt of payment with rebate application, or complete a Consumer Use Tax form. Proof of paid sales tax is waived when appliance is purchased and installed by a licensed contractor.

**Approval and verification:** The Washington utilities, State of Washington and/or their respective agents reserve the right to verify sales transaction and to have reasonable access to your residence to inspect the system installed under this program, for up to six months after date of application.

**Application and Rebate Payment:** This application must be filled out completely, truthfully and accurately. The customer must sign and submit the completed application along with a copy of the dated invoice/sales receipt, refrigerator recycling or decommissioning documentation, and a copy of his/her State ID or utility bill dated 90 days or less from appliance purchase date. Rebates will be processed on a first come, first serve basis. On a daily basis, Monday through Friday (excluding holidays), applications received via mail will be processed first, followed by applications received via fax, lastly followed by applications received via email. Please allow 4-6 weeks from receipt of completed application to process and mail rebate check. Please contact Cash for Appliances–Washington at (877) 304-9225 to inquire about the status of a rebate application.

**Clothes Washer Incentive Increase:** The Clothes Washer rebate amount has increased from \$100 to \$150. Any customer who has received and/or submitted an application for a \$100 Clothes Washer rebate will automatically be sent an additional check for \$50. It is not necessary to submit an additional application. Please expect the additional check to be mailed within approximately 8 weeks of program changes.

**Tax Liability:** The Washington utilities, State of Washington and/or their respective agents will not be responsible for any tax liability that may be imposed on the customer as a result of the payment of the rebate.
